1. Certified high school TRANSCRIPT showing GPA and class rank.
 2. A typed essay of no more than 500 words. This PERSONAL STATEMENT should describe your individual character and accomplishment, your educational goals and why you are interested in studying real estate, entrepreneurship/business, and/or franchising. It should also describe someone (not a family member) who inspires you and explain why he or she inspires you.
 3. On one sheet of paper, describe any COMMUNITY SERVICE activities in which you have participated in the past four years, including the number of hours per week spent on the activity and how many days, months, or years you participated in the activity; and WORK EXPERIENCE you have had in the past four years, including your length of employment, the numbers of hours you worked, and how much you earned.
 4. At least one, but no more than two, LETTERS OF RECOMMENDATION written on your behalf by persons not related to you (such as teachers, counselors and supervisors). One of the recommendations must come from the supervisor of a recent work or community service experience. The letters should be delivered in sealed envelopes with the application, and the persons signing the letters should also write their signatures across the flap of the sealed envelope. Each of your references should include a telephone number where he or she can be reached during the business day.
- It is the responsibility of each scholarship applicant to submit all of the required items on or before the application deadline of **March 1, 2009**.
